At the last CAPP meeting the area did not identify any priorities to be looked at in this area.

I have been made aware by PC Dalziel that there are ongoing issues regarding parking on Zig-Zag lines at Gullane and Aberlady, this is something I will continue to monitor however in my first 3 of weeks in the role I have carried out patrols of the area and so far have not experienced any issues so hopefully previous enforcement is having the desired effect.

I have been made aware this week of an incident regarding youths climbing on the roof and being a general nuisance at Drem Railway Station. This was attended by British Transport Police but this is something PC Jackson and I will monitor in the coming weeks especially with the school holidays due to commence in the coming week. I would encourage residents to contact Police if they witness any similar behaviour in the coming weeks so that we can try and ensure this does not become a regular occurrence.

I will be attending at the next CAPP meeting and will introduce myself further then.
