#### Foreword from PC Diane Bath

At the last CAPP meeting Youth Anti Social Behaviour at East Road, North Berwick was identified as a priority.

Apologies that this report has been produced a little bit earlier than would usually be the case due to me being on annual leave shortly. I look forward to catching up with you all at the next CAPP meeting.

Although youth ASB has been a lot quieter this last month, I have had a report of a couple of incidents that have occurred at the skate park, North Berwick. As a result of this I will be paying extra attention to this area.

As Halloween is approaching, I anticipate further youth ASB calls particularly eggs being thrown at houses. I would ask that anyone witnessing this with ring door camera footage report the incidents to myself then I can try and get the culprits identified and advise them and their parents on their behaviour.

I have set this as a priority and will carry out some late afternoon/evening and weekend patrols.

Your Community Policing Officer will not routinely attend Community Council meetings unless specifically requested in response to specific issues. The officer will attend the CAPP (Community & Police Partnership). The CAPP meeting is for elected members and local representatives to agree local priorities; therefore all community councils are encouraged to have a representative attend.

Between 24<sup>th</sup> September 2024 and 23<sup>rd</sup> October 2024 there were 50 calls to the area. This resulted in the police recording 9 crimes as follows:
